Notice is hereby given that, pursuant to Section 15.2-1800 of the Code of Virginia, 1950, as amended, the Board of Supervisors is considering the sale of a portion of a certain tract or parcel of land, lying and situate in the Saluda District, Middlesex County, Virginia, containing 2.85 acres more or less, said parcel being a portion of Tax Map 30-110 (Hummel Airport) and being more particularly described as follows:

BEGINNING at a point intersecting the common boundary line between the property formerly owned by the Lawson Trust, now owned by Delaware Corporation, W75 Hangars, LLC and the County of Middlesex, said point lying approximately 451.84 feet east of the east line of Plainview Road.
